The LEED-certified Agricultural Innovation Center includes a greenhouse for live plant testing and research, a training center for formulation development, a spray chamber for studying driftable fines, a Class II lab to support biological formulation development and state-of-the-art laboratories dedicated to liquid and dry formulation design. The temperate climate in Georgia will enable Stepan to test year-round and help accelerate the rate at which products are moved to large-scale production.

Stepan expects the facility to contribute to the development of the agricultural industry in Barrow County and the industry at large. Stepan hopes to be a resource for students and area residents as the new facility is near the University of Georgia, Emory University and other academic institutions with strong agricultural programs. Stepan is a current partner with Emory University in its <u>Sustainability and Resilience Collaboratory</u>.
